Award

Greylock will award two students from each public high schools in Berkshire County a \$500 scholarship, to be applied toward tuition at a state-accredited or nationally-accredited two or four-year college/university.

Essay

- Be no more than 300 words in length, typed. Times New Roman, 12 point font, 1 inch margins
- Have a header containing full name, contact information, and high school

Essay Topic

Describe from the perspective of your field of interest what you would do to make the Berkshires the perfect place to work, play, and live.

Eligibility

Applicant must meet the following criteria:

- Be a member in good-standing with Greylock Federal Credit Union prior to applying
- Demonstrate an outstanding level of community and volunteer work
- Must be a college-bound senior attending a public high school in Berkshire County at the time of application

Application

To apply, members must fill out the Scholarship Application Form.

The application must be returned no later than **April 20, 2018**.

Each school will be notified of the chosen scholarship recipients by **May 7, 2018**.
