Nominating Committee

In accordance with its bylaws, Greylock Federal's Nominating Committee submits the following slate of three candidates for re-election to a three-year term at the Annual Meeting:

Gerard E. "Jerry" Burke – nominated for 3-year term

Jerry was elected to the Board in 1999. Jerry has 27 years of board service including being Board Chairman from 2013 – 2017. Director Burke currently chairs the Board Governance/Bylaw committee and serves on the Compensation committee. He also serves on the Greylock Financial and Insurance Services LLC (CUSO) board. Jerry recently retired as President and CEO of Hillcrest Education Centers and holds a master's degree in business administration from Western New England College, a master's degree in counseling psychology from Anna Maria College, and a bachelor's degree in special education from Fitchburg State College. Director Burke also serves on the Board of Trustees of Berkshire Integritus, Inc. Jerry currently lives in Harwich, MA with his wife Kate.



Sheila A. LaBarbera – nominated for 3-year term

Sheila joined the Board in 1999 and currently chairs the Loan Policy Committee; she also serves on the Compensation and Asset Liability (ALCO) committees. Sheila was also the first woman to serve as Chairman of the Board of Directors, serving from 2009 to 2013. She earned both a bachelor's and master's degree in business from Western New England College. Sheila is the Executive Director of the Berkshire County Retirement Board. An avid golfer, she is a member of the BHCC. She lives in Pittsfield with her dog Dutch.



Ty Allan Jackson – nominated for 3-year term

Ty joined the board in November 2015 and currently chairs the Community Support Committee and serves on the Loan Policy committee. He also serves on the Greylock Technology Group (CUSO) board. Ty is the founder of Ty Allan Jackson LLC and co-founder of the Read or Else movement. His books have been featured on CNN, NBC, PBS, and other news outlets, and were gifted to former First Lady Michelle Obama. He is a Bronx, NY native, who continues to create entertaining and educational content that inspires young readers. Ty currently lives in the Bronx.



Board candidate nomination petitions

Greylock members who are interested in running for a seat on the Board of Directors may request a Nomination Petition at any open Greylock branch. To qualify, a member must be age 18 or over, and submit a completed Nomination Petition (including a signed certificate from the member stating that the member is agreeable to such nomination and will serve if elected), 500 signatures of current Credit Union Members, a statement of qualifications, and biographical information similar to those listed.

Candidates must return completed Nomination Petitions directly to SVP Administration JamieEllen Moncecchi at 150 West Street, Pittsfield no later than 4:00 p.m. on February 12, 2026. No Nomination Petitions will be accepted after this deadline. For more information on Nomination Petitions, call 413-236-4103.

Voting procedures

In accordance with the Bylaws, because the number of Nominees put forth by the Nominating Committee is equal to the number of open seats, nominations from the floor will not be allowed. Elections will not be conducted by ballot, unless properly submitted Nomination Petitions result in there being more Nominees than open seats, in which event virtual ballots will be included. The order of other business will be announced at the meeting.
