INTEREST RATES AND INTEREST CHARGES	
Annual Percentage Rate (APR) for Purchases	10.25 % to 18.00 % based on your creditworthiness. This APR will vary with the market based on the Prime Rate.
APR for Cash Advances	10.25 % to 18.00 % based on your creditworthiness. This APR will vary with the market based on the Prime Rate.
APR for Balance Transfers	10.25 % to 18.00 % based on your creditworthiness. This APR will vary with the market based on the Prime Rate.
Paying Interest	Your due date is at least 25 days after the close of each billing cycle. We will not charge any interest on the portion of the purchases balance that you pay by the due date each month. We will begin charging interest on cash advances and balance transfers on the transaction date.
