Nominating Committee

In accordance with its bylaws, Greylock Federal's Nominating Committee submits the following slate of three candidates to fill the open seats for election at the Annual Meeting:

Colleen Holmes - 3 year term

Colleen White Holmes joined the Board in 2018 and serves on the Loan Policy and Governance/By-Laws committees. She is the President and CEO for Viability, Inc. and the former President and CEO of 18 Degrees. Colleen's career has centered on capacity-building with people and organizations. Her background includes work advancing organizational development with national and local organizations in transportation, banking, state government, and human services. Colleen earned her bachelor's degree in Public and International Affairs from Princeton University's Woodrow Wilson School and her Master of Business Administration degree from American International College. A former dancer and choreographer who taught extensively at studios in the Northeast, Colleen continues her work in the dance world in the Pioneer Valley.

John Law - 3 year term

John was elected to the board in 2015. He serves on Greylock's ALCO, Loan Policy, and Compensation committees and chairs the Board of Managers of Greylock Financial and Insurance Services LLC (CUSO). He recently retired as Vice President for Administration & Finance and Chief Financial Officer at Berkshire Community College. Prior to

that position, John had twenty-nine years of experience in the financial services industry. He received a B.A. from Williams College and an M.B.A. from the Darden School of Business at the University of Virginia. John has served as past president of Northern Berkshire Community Coalition and Northern Berkshire United Way as well as director of Berkshire Chamber of Commerce, Northern Berkshire YMCA, and Higher Ground. Peter Lopez – 3 year term

Pete joined the board in December 2016 and brings breadth and depth of experience in information technology and business process improvement. Board candidate nomination petitions

Greylock members who are interested in running for a seat on the Board of Directors may request a Nomination Petition at any open Greylock branch or drive-up window.

To qualify, a member must be age 18 or over, and submit a completed Nomination Petition (including a signed certificate from the member stating that the member is agreeable to such nomination and will serve if elected), 500 signatures of current Credit Union members, a statement of qualifications, and biographical information similar to those listed.

Candidates must return completed Nomination Petitions directly to Senior Vice President, Chief Administrative Officer, Jamie Ellen Moncecchi at 150 West Street, Pittsfield no later than 4:00 pm on February 11, 2021. Voting procedures

Voting procedures - In accordance with the Bylaws, because the number of Nominees put forth by the Nominating Committee is equal to the number of open seats, nominations from the floor will not be allowed. Elections will not be conducted by ballot, unless properly submitted Nomination Petitions result in there being more Nominees than open seats, in which event virtual ballots will be included. The order of other business will be announced at the meeting.
